This year the Southwest Detroit Immigrant and Refugee Center passed a significant milestone: we turned 5! When I started this organization five years ago I did so in hopes of meeting an immediate need. Two of the most prominent resources for free legal help in the Detroit area closed within a short span of time. I had been volunteering with one of them and got the

call to come help when the service provider didn't show up but the clients seeking help did. More than five years of Wednesdays later and the Southwest Legal Clinic is our strongest program, having helped hundreds and hundreds of families in that time.

2019 has been a year of superlatives for us as well: we've served more people, seen more volunteer hours, and delivered more legal services than ever before! The Southwest Legal Clinic has always been our most popular but we are seeing accelerating growth in our Pontiac and Eastside Clinic

as well.

SWIRC is also making progress on the property we have purchased on West Grand Blvd. in Southwest Detroit. We have completed immediate structural renovations and have started work with the Detroit Collaborative Design Center and 4545 Architecture on plans for the house. I am excited to share the design renderings as our vision comes to life, even if it is still just on paper.

Despite the national rhetoric around immigrants, despite shrinking budgets and changes in giving, I am hopeful. Our volunteers, who contribute so much time, skill and energy for our clients make me hopeful. Our clients, who continue to fight for a better life for themselves and their families, make me hopeful. You, who cared enough to read this whole message, make me hopeful!



Stories from Our Clients

Mario is a 22-year old native of Detroit. He's active in his church and loves his country. During a visit with family in Mexico in 2018, he fell in love with Juanita and decided his life would only be complete if they marry and she joined him in the U.S. In the past, the application process for immigrants who married U.S. citizens was rather simple. Recently, however, fees have risen dramatically and applicants must prove that they can support a family here without public assistance. Since these new rules were established, the rate of rejected visa applications has doubled.

Mario first sought help from a private attorney, but he could not afford the legal fees on top of the application costs. He came to SWIRC and we helped him prepare his applications, assemble all the documents and identify a financial sponsor who pledged to support the couple if they needed assistance. Because of our help, this new family's applications were approved! She nailed her interview at the U.S. Consulate in Ciudad Juarez and was granted permission to enter the United States as a permanent resident.

Her father worked in a factory and her mother kept their seven children fed, dressed, and focused on school. The house where they all lived has been owned by their family for more than 50 years. Before her mother died in 2017, Charlene moved back to her childhood home to care for her. After both her parents had passed she didn't know how to change the title to her own name, so she came to the Southwest Legal Clinic for help.

Together, we prepared all the documents for the onerous Wayne County Probate process and helped her get written approval from all her relatives that she should be given the title. The Wayne County Probate Judge agreed and awarded her the house.
